STUDY TOUR TO CROATIA & SLOVENIA

In 2022 you have the opportunity to join a study tour to **Croatia & Slovenia**. This tour, restricted to a total of **20 participants (Principals, Directors and/or DPs)**

Is being organised by **LEAP Australia** in conjunction with **European School Heads Association**.

ITINERARY: This Croatia & Slovenia Study Tour includes:

- ★ 5 night's accommodation (incl breakfast) in Zagreb, Croatia, April 10th – 15th
- ★ 4 night's accommodation (incl breakfast) in Ljubljana, Slovenia, April 18th – 22nd
- ★ From Monday April 11th to Thursday April 14th (in Croatia) will explore:
 - ✓ The Croatian education system & School visits
 - ✓ Student projects at international and national levels (e.g. Erasmus Program)
 - ✓ Implementation of cross-curricular topics
 - ✓ Strong tradition in teaching and promoting coding
 - ✓ Lowest level of student drop out in Europe
- ★ From Tuesday April 19th to Thursday April 21st (in Slovenia) we will explore:
 - ✓ The Slovenian education system & School visits
 - ✓ Principals; their preparation, their role & their wellbeing (National Institute for Leadership in Education – endorsed by OECD)
 - ✓ Strong Early Childhood programs
 - ✓ Strong VET programs
 - ✓ Inclusion of children with special needs in regular educational programs
- ★ Opportunities for free time to explore the cities at the conclusion of the working day
- ★ The middle weekend (Friday April 15th – Monday April 18th is Easter) free time.

COSTS

- ★ The cost of the tour (with the program listed above) including ground transport to PL meetings, lunches and school visits is **\$4,800.00** (single accommodation only).
- ★ **NB: Withdrawal after January 31st 2022 may result in no refund of instalments paid.**
- ★ Participants are responsible for their own air fares, visas and travel insurance plus the costs of getting to and from the airport.
- ★ Participants are responsible for their evening meals plus the free weekend (including travel to Ljubljana, Slovenia, for the second week).
- ★ The permissible use of non-personal funding sources is the individual responsibility of each person.

HOW TO JOIN THE STUDY TOUR

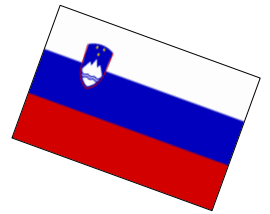
1. On a "first-in" basis email EOI to warren.f.marks@det.nsw.edu.au or suzanne.lazenby@gmail.com
