ITINERARY

This BC Study Tour includes:

- ★ 4 night's accommodation (incl breakfast) at the Holiday Inn, downtown Vancouver **check-in Sunday 14th April check-out Thursday April 18th**
- ★ 3 night's accommodation (incl breakfast) at the Holiday Inn, downtown Vancouver **check-in Monday April 22nd check-out Thursday April 25th**
- ★ From Monday 15th to Thursday 18th and Tuesday 23rd and Wednesday 24th we will explore:
 - ✓ **The BC system (Ministry & local boards): how do the pieces fit together?**
 - ✓ **Equity programs**
 - ✓ **First Nations programs**
 - ✓ **Teacher preparation and performance appraisal**
 - ✓ **Principals: their preparation, their role & their wellbeing**
 - ✓ **Primary and Secondary school visits**
- ★ Opportunities for free time to explore Vancouver at the conclusion of the working day.
- ★ Easter 4-day break from the study tour (**Friday April 19th to Monday April 22nd**) to explore beautiful BC based on a self-funded and self-organised program, with return to Vancouver Holiday Inn on the evening of April 22nd.

COSTS

- ★ Participants are responsible for their own air fares, visas and travel insurance plus the costs of getting to and from Vancouver airport.
- ★ Participants are responsible for their evening meals plus the Easter break as outlined above.
- ★ The costs of the tour (with the program listed above) including ground transport around Vancouver to meetings, lunches and school visits (**Monday 14th - 18th plus Tuesday 23rd and Wednesday 24th April**) is **\$4,600.00** (single accommodation).
