ITINERARY

This 10-day Scotland Study Tour includes:

- ★ 5 nights in downtown Glasgow (including breakfasts)
- ★ 3 nights in Edinburgh (including breakfasts)
- ★ Educational leadership program (including lunches) involving:
 - ✓ Teaching Council of Scotland
 - ✓ Overview of the Scottish system: Education Scotland
 - ✓ Local Authority Governance
 - ✓ Teacher and Principal preparation
 - ✓ Role of Head Teachers in Scotland
 - ✓ Teacher and Principal Wellbeing
 - ✓ Scottish Curriculum
 - ✓ Special Education Provision
 - ✓ Primary/Elementary and secondary school visits in Glasgow
- ★ Opportunities for free time to explore Glasgow and Edinburgh at the conclusion of the working day.
- ★ A free weekend (Jan 18/19th and 19/20th) to explore the broader area based on a self-funded and self-organised program, with arrival in Edinburgh on the evening of Sunday January 20th.

COSTS

- ★ *Participants are responsible for their own air fares and travel insurance plus the cost of getting both to and from the airport (Glasgow and/or Edinburgh).*
- ★ *Participants are responsible for their evening meals.*
- ★ *The cost of LEAP Study Tour (with the inclusions as outlined in the itinerary above) is \$5,000** (single room accommodation only).*
